## **BOC Short Message Service (SMS) Platform Terms and Conditions**

1. All Accountholders and their Joint Accountholders (where applicable), who have an account, including savings, checking, time deposit and debit card with the Bank of China (Hong Kong) Limited - Manila Branch ("BOC") ("Accountholders") will be enrolled in the BOC Short Message Service when they apply for the same.
2. In the case of joint accounts, all Accountholders must sign on the Application form.
3. The instruction herein will supersede any previous settings of the BOC Short Message Service.
4. The BOC Short Message will be sent only to the registered mobile numbers. BOC shall not be held liable if the Accountholder fails to provide and/ or update his/ her registered mobile phone numbers with BOC. Accountholder will be responsible for the accuracy of his/ her registered mobile phone numbers provided by him/her to BOC.
5. The Accountholder authorizes BOC to notify him/her of each BOC Short Message via the registered mobile phone number as provided by him/ her in this form or as registered with BOC.
6. The Accountholder acknowledges and accepts that each BOC Short Message sent to him/ her is not encrypted and may include his/ her personal details, details of his/ her transactions and information pertaining to his/ her account(s).
7. The Accountholder understands that his/ her receipt of a BOC Short Message is subject to his/her mobile phone operator being able to support the BOC Short Message Service, the relevant terms and charges of his/her mobile phone operator/ service provider.
8. BOC is not responsible for any applicable charges and fees imposed by the Accountholder's mobile phone operator/ service provider.
9. The use of BOC Short Message Service does not:
  - a) free the Accountholder (s) from the responsibility of safeguarding the physical security and authorised usage of his/ her account(s).
  - b) imply that BOC will be liable for any unauthorized transactions that may occur to a BOC account.
10. The Accountholder acknowledges and agrees that his/ her application to amend the threshold amount settings for the BOC Short Message Service is subject to BOC's approval at its absolute discretion and BOC reserves the right to refuse or terminate any request by him/ her at any time, without prior notice and without having to disclose any reason and without any payment or compensation whatsoever.
11. The Accountholder acknowledges and agrees that BOC does not warrant the quality, delivery, accuracy, security or confidentiality of the contents of a BOC Short Message and shall not be responsible for any consequence in connection with the BOC Short Message Service. BOC shall not be liable to an Accountholder or any third party for any losses or damages arising from the BOC Short Message Service including but not limited to:
  - a) a non-delivery, delayed delivery, wrong delivery or partial delivery of the BOC Short Message
  - b) inaccurate contents of the BOC Short Message Service
  - c) access to the contents of the BOC Short Message Service by any unauthorized persons
12. The Accountholder acknowledges that alerts received through the BOC Short Message Service are for reference only and cannot be used as proof of confirmation of the transaction.
13. The Accountholder acknowledges and agrees that BOC shall be entitled to amend, vary or supplement any of the terms and conditions relating to the BOC Short Message Service at its sole discretion from time to time.
14. The Accountholder acknowledges and agrees that the decision of BOC on all matters relating to the BOC Short Message Service is final, conclusive and binding on him/ her and no correspondence will be entertained.
15. The Accountholder acknowledges and agrees that the general terms and conditions signed upon account opening will apply to his/ her use of the BOC Short Message Service.
